Terms and Conditions

New Subscribers pay an initial upfront connection fee and their FIRST Tech partner Subscription payment (Monthly or Annually) prior to receiving the software. Subsequent payments or a renewal of a contract without lapse will not incur any further connection fee. Your software will be posted to you within 10 days of receipt of payment.

The minimum term of a Tech Partner Subscription contract is 36 months. In becoming a subscriber, you agree to pay every expected subscription payment for the entire contract, either in equal monthly instalments, or as an annual amount each year. Necessary steps will be undertaken by **i•Agri Ltd** to recover any monies outstanding.

The ***License and subscription start date*** is calculated as being the 20th day of the month following the receipt of your first payment and connection fee to **i•Agri Ltd**. All subsequent payments, be they annual or monthly will be based on the ***License and subscription start date***.

Monthly Subscription Payments (for New and Existing Clients), must be in **i•Agri's** bank account by the 20th of each month subsequent to the ***License and subscription start date*** for the period of the contract. It is the subscriber's responsibility to ensure that their automatic payment is processed by the bank on time and for the correct amount.

Clients who choose to pay annually will be invoiced on a twelve monthly basis for the period of the contract. This will occur in the same calendar month as the ***License and subscription start date***. Clients are to ensure that their payment is received in the **i•Agri Post Box** on or before the 20th of that month.

A lapse of payment will render the software un-usable after a period of time. Renewal of a contract that has lapsed will incur a connection fee.

If you anticipate problems with your payment, please contact the **i•Agri** office as detailed above. Any costs incurred in the collection of your overdue account will be passed on to you, the client.
